- 1. Clozapine (Clozaril), a tricyclic dibenzodiazepine, is used for the symptomatic management of psychotic disorders and is considered an atypical antipsychotic drug.
- 2. The agranulocytosis that occurs in approximately 1% to 2% of patients can be controlled with close hematologic monitoring.
- 3. Clozapine is metabolized to desmethylated and N-oxide derivatives. The desmethyl metabolite (Norclozapine) has only limited activity, and N-oxide metabolite is inactive.
